

## Why is COPCA recommending the collation of names of those working in the Church?

1 All those who work, or apply to work, in a role with children and/or vulnerable adults will be required to apply for ISA scheme membership. The scheme applies to those in paid and voluntary roles and is mandatory.

1 It will be a criminal offence for an organisation to employ (this also relates to volunteers) a person to work in "regulated activity" (*meaning in summary any specific activity that involves frequent, intensive or overnight contact with children or vulnerable adults in and certain defined positions of responsibility*) who is barred OR has not yet been registered onto the ISA scheme. It is also a criminal offence for an organisation to employ a person to work in "regulated activity" who has NOT been checked for their ISA scheme membership status.

Employers will be subject to penalties if the legislation in this regard is breached. The penalties are a £5000 fine or 5 years imprisonment or both. Therefore in order to protect all those within the Church who would be deemed to be "employers" i.e. Diocesan Trustees for example; COPCA has recommended that information be gathered regarding all those post holders who work with Children and/or Vulnerable Adults; those who work within adult social care or educational settings including the ancillary support roles (this relates mainly

to the Religious); and those who volunteer their services in a multitude of capacities within a parish setting. Until ISA publish the final guidance regarding the specific roles that are considered "regulated" \* or "controlled" \* (*this relates to frequent or intensive support work in health settings, the NHS, adult social care and further education settings*) activity, COPCA is encouraging that details of all volunteers are gathered. This ensures that those who will fall within the remit of the scheme can immediately be identified. Otherwise parishes, Orders and Dioceses may have to gather additional information of applicable categories of worker covered by the Scheme at a later date.

\* Further information will be provided regarding "Regulated" and "Controlled" activities once the Independent Safeguarding Authority issues its published Guidance.

### Did you know....

The ISA service will extend to England, Wales and Northern Ireland, *although arrangements for application and appeals may differ slightly in Northern Ireland.*

A separate but similar scheme is being set up in Scotland. Anyone included on a Barred List in Scotland will also be barred from working with children and vulnerable adults across the UK.
